Departmental Updates with Dr. Hsieh-Yee and Dr. Choi

CUA did a good job on the accreditation materials; the ALA committee seemed pleased with them and was very complimentary towards them. They said no more major edits are necessary and if anything needs to be added, it can be done with addendums. The body of the Self Study draft is composed of six chapters addressing the different aspects of the program. They were especially concerned with enrollment and leadership stability in the program since it currently is co-chaired by two interim chairs and the school has an acting dean. The department is addressing all of this. We created a professional hard copy and a version on a jump drive, complete with hyperlinks, for more details for the reviewers. We are also trying to get a good, solid turnout for the Site Visit on Sunday April 3rd. We need lots of people to come, the more that come, the better it looks. Need to reach out to alumni, current students, and employers of CUA students. The employers are tricky to reach out to, but we are sending out invitations to Library of Congress, DCPL, DOJ, Smithsonian, NARA and local university libraries, places where we know our graduates are employed.
