

Grading Comprehensive Examination Essay

In grading the exam, faculty members look for the understanding of core concepts, adequate knowledge of facts, and application of principles and problem-solving skills in the library and information science field and profession.

Faculty members will evaluate the essay using the rubric below. Although faculty evaluate the essay with the rubric, the goal is to reach a holistic judgment regarding the piece of work. The essay will receive “pass” or “fail.”
